GENERAL RULES

1. EVERY PERSON RESIDING IN THE HOUSE MUST BE A MEMBER.
2. Children who have not reached their 2nd birthday by 6/1 do not require a tag.
3. NON-MEMBER RESIDENTS OF INDIAN LAKE DO NOT QUALIFY AS GUESTS, ARE NOT PERMITTED ON CLUB PROPERTY, AND ARE NOT TO ATTEND CLUB FUNCTIONS.
4. Swim at own risk when Life Guards are off duty/ICE SKATING IS AT OWN RISK.
5. Tags are to be worn whenever Members are on ILCC property.
6. Definition of a child is a family member under 23 years of age.

UPKEEP FEE: Fees must be current prior to Membership.

MEMBERSHIP:

SENIOR-In a household where one or two adults reside, and one of the adults is 62 or older by 6/1, the rate is \$125.00.

SINGLE-The rate for a single adult is \$220.00. (If two adults reside in household, both need to join).

COUPLE: The rate for a couple is \$315.00.

CHILDREN: The 1st and 2nd child's tags are \$25 each. The 3rd and 4th child's tag are \$15 each. There is no charge for additional children. *Please note that children over the age of 23 are considered "Additional Residents".*

ADDITIONAL RESIDENTS: Anyone over the age of 23 may be granted membership at the rate of \$80 each. This charge is *in addition* to the *Membership* fee.

SEASON BEACH TAGS: Available to children and grandchildren of members who do not reside in Indian Lake at the rate of \$80.00 each. This charge is *in addition* to the *Membership* fee.

HIGH POWER BOAT STICKER: Fee is \$100.00. The maximum horsepower is 115 hp for outboards, and 130 hp or 3 liter for an I/O. The Boating Trustee must inspect boats new to Indian Lake. ***A copy of the current Insurance Certificate and NJ registration must accompany the Membership Application EACH YEAR.*** Non-compliance will prohibit a boat from being used on Indian Lake.

LOW POWER BOAT STICKER: Fee is \$50.00 for all electric and gas powered boats under 10 hp. All rules applying to high power boats also apply to low power boats.

NON-POWER BOAT STICKER: Fee is \$25.00. This includes rowboats, sailboats, canoes, paddle boats, kayaks and inflatables. All boats on ILCC Property must have current tag. Boats left on Lake Landing must have current tags as of June 1st.

GUEST TAGS: Members may bring Non-Indian Lake Residents guests to any Indian Lake function or to the beach. Prepaid guest tags are available from the Membership Trustee at any time - 10 for \$20.00 or 20 for \$40.00. They are also available at the snack shop.

**** GET 25% OFF YOUR ADULT MEMBERSHIP PORTION BY SPONSORING A NEW MEMBER ****

If a New Member joins the club and identifies you on their application as the "Sponsor Member", you will receive a refund check for 25 % off the Adult Membership portion.

(I.e. \$315 x 25% is a \$78.75 savings).

To Qualify: (1) your name must be put on the application as "Sponsor Member", and (2) both the new and sponsoring member's application must be submitted by June 1, 2011.

A "Sponsor Member" can sponsor up to four (4) new Membership's resulting in a FREE Adult Membership. A check will be mailed to you for the refund portion.

Please note: the discount only applies to the Adult Membership portion.
