## *President's Message*

*Greetings ILCC Members and Indian Lake residents!*

*I want to start my message with a big thank you to Russ Bauer, Pete Bedell, Rick Merrill, Matty Heinbockel and Al Wilson. This great bunch of guys volunteered to run new electric service to the relocated horseshoe pits and to re-run the electric that powers the swim lanes and gazebo. Without their help swim meets and fun weekend would have been a huge challenge. So thank you, guys, it is that kind of volunteerism that is the heart of the success of our community and it is something, by the way, that we all need to refocus on, as it has fallen off dramatically in recent years!*

*The balance of my message this month will be used to bring everyone up to date on the Indian Spring Pond dam situation you may be hearing about. This is the small dam directly across East Shore Road from the Clubhouse. The owners of 88 East Shore Road have been trying to sell their property, which is adjacent to the dam and several surveys do exist that seem to show the majority of the dam to actually be located on their private property. They have had several potential sales fall through recently because buyers have raised questions about who actually owns and is responsible for the dam. Unfortunately, there are no records of who originally constructed the dam, nor are there any records of any repairs or maintenance having been done to the dam or whether it has ever been inspected by the state.*

*Last year, the New Jersey Department of Environmental Protection, (NJDEP), was made aware of the situation and after reviewing documents provided to it, ruled that it considers both the homeowners and the ILCC to be 'co-owners' of the dam and ordered that we both pay to have the dam inspected immediately. While at the time disagreeing with the DEP's ruling, we arranged for our dam engineer to inspect the dam and file a report with the DEP to avoid the large daily fines being threatened. As was expected, the report indicated that the dam is in poor condition and in need of repairs that could cost somewhere between \$50,000 and \$100,000.*

*On February 6, 2015, the homeowners filed a lawsuit against the ILCC and asked the Court to rule that the ILCC is the sole owner and operator of the dam and therefore totally responsible for all current and future costs of its repair and maintenance. Based on research we have done, the Board has decided that it is in the ILCC's best interests to attempt to negotiate a settlement involving a one-time payment of some amount by the homeowner towards the costs of repairs in return for the ILCC assuming total responsibility for the dam going forward and we are in that process now.*

*I want to be clear that while this is will be a significant financial 'hit', the Club is in no danger of going bankrupt! And, even if the dam totally collapsed catastrophically tomorrow, which it is in no danger of doing, the only property that might suffer some minor damage would be the ILCC garage.*

*I will tell you that the 18 owners of the property on the pond have already organized themselves and committed to the Board to take the lead in raising funds for the repairs. In addition, the Board may have to ask all members and property owners for a one time additional contribution to help defray the repair costs at some point in the future, but we've done that in the past when the seawall along the swim lanes collapsed unexpectedly, and we were able to raise all we needed to pay for a brand new seawall.*

*So, I'm confident we'll respond to this challenge in a similar way and come up with whatever we need to put this dam back in shape to serve all of us for many, many more years to come, and as always, I'm so very grateful for all your support!*


